Accessible Tourism: NECSTouR's Common Definition

"Accessible tourism means dealing with the entire holiday value chain to make services and facilities without obstacles for everyone in an inclusive way and designed for all.


Consultation and collaboration with all private and public partners is essential.

To increase the accessibility of the touristic area, information is important to improve mobility, inclusion and territorial cohesion. That will provide a new demand for the accessible regions" NECSTouR

NECSTouR Regional Common SWOT Analysis

Accessible Tourism Task Force, together with NECSTouR, created a SWOT analysis (Strong, Weakness, Opportunities, and Threats) for each of the five axis analysed, that aims at providing a general vision of the current state of play of the accessibility integration within the tourism value chain.

Some opportunities and threats arised from the SWOT analysis:

Opportunities:

- Accessibility is transversal and entitles integrated approach and coordinated policy measures from a destination perspective. Cooperation is needed
 - Accessibility is sustainability
 - Accessibility brings social responsibility, economic benefit, quality and differentiation to destinations
 - Accessible tourism is a lever for innovation, ICTs and new services Every tourist has special needs (families, elderly people...).

Threats:

- The accessible tourism value chain is vulnerable:
- Accessible transport and accessible connections: need big infrastructure changes
- Difficult to monitor the accessible enterprises registered in the Regional DDBB
- Still need the tourism professionals to be better trained to welcome disable people.



Proposals for European Action on Accessible Tourism

- 1) **Accessibility** progressively **integrated** in EU policies and financial instruments
 - 2) A **common language** for design, implementation and promotion
 - 3) Scope for a **New Preparatory Action** in the field of accessibility 2015-2017
 - 4) A **Tourism Intergroup** dealing with accessibility
